### **Opening:**

#### **A. Approval of Agenda**

#### **B. Approval of Minutes**

#### **C. Open Issues**

#### **President-**

- Mike said he talked to Jaime about refs-U10, U12, and U14 only.
- He will address an issue between Garydon and Manual. Stressed a time and place for discussions between coaches.
- Another issue between Mark Smith and a parent on a team will be discussed after the meeting. Mark stated that he did not want to discuss it until after the meeting.
- Mike addressed the U14 fields needing to be measured again and Jaime stated he would take care of that field.
- Mike addressed the cases of paint the league has to strip fields. It was agreed that a paint inventory sheet needed to be made so the league can keep track of the cases.

- Jennifer suggested that one way to help cover costs would be to bump Spring memberships from \$30 to \$35 on returning players.
